

The Art League of Ocean City, Inc. (ALOC)
Exhibit Entry Form

ELIGIBILITY: Open to all artists 18 years and older, professional or amateur. **ALL WORK MUST BE ORIGINAL AND COMPLETED WITHIN THE LAST THREE YEARS.** No direct copies will be accepted. Any work shown in a previous exhibit at ALOC may not be shown again. The Committee reserves the right to reject any work not suitable for this exhibit. **Entry fees will not be returned.**

ENTRIES: Entries must be dry, properly framed and ready for hanging with picture frame wire. There is a limit of two (2) entries per artist. Please check with ALOC for size limits**. For photographic entries, see photography guidelines.

FEE: \$10 per entry for members; \$15 per entry for non-members. Entry fee will not be returned.

AWARDS: First, \$125; Second, \$100; Third, \$75. Ribbons for First, Second and Third and Honorable Mention.

SALES: ALOC retains a commission of 30% of the sale price for any piece sold during the exhibit.

ENTRY FORM: Complete the entry form and make your check payable to **THE ART LEAGUE OF OCEAN CITY, INC.** Submit both with the delivery of your work. The attached entry label forms must be filled in completely and attached to the back of each item entered – **POSITIONED IN THE UPPER RIGHT HAND CORNER OF THE WORK (LEFT CORNER, LOOKING AT THE BACK).** On work other than framed art, such as sculptured pieces, the labels should be affixed on the bottom or back so as not to be visible when displayed. All information also must be entered in the ledger.

DELIVERY: Entries will be accepted from 1:00-4:00 pm only on the entry dates specified on the exhibit schedule. All accepted work will remain in the exhibition as placed by the Exhibit Committee for the **Duration** of the exhibit. It will not be subject to withdrawal by the artist under any circumstances. The last day of the exhibit will be the **ENTRY DATE** for the next exhibit. At this time, old work should be removed. ALOC is not responsible for work left after this date. Lack of storage space may result in damage. Any art work left for more than 3 months will become the property of ALOC.

INSURANCE: The Art League of Ocean City, Inc. will **NOT** be responsible *at any time* for loss or damage to entries, no matter how it may be caused. **YOUR** signature on the entry form constitutes **YOUR** acceptance of the entry conditions.
